General Information:

The Festival will take place Sunday, May 6, 2018 in downtown Kennett Square, PA (State Street between Broad and Lafayette Streets). Festival hours are from 11 AM – 5:00 PM. This is an outdoor street festival and will be held rain or shine.

Application Procedure:

Vendors shall submit their application and will receive confirmation once the application has been processed and accepted by the Organizing Committee. Vendor space preferences will be considered, however space allocation will be by the committee and will be final.

General Rules (Please read complete form carefully):

- All vendors must have a tent during the event. You can either supply your own 10' X 10' canopy or rent one through the Organizing Committee. See cost below. Please note sand bags required (4) for wind.
- All displays and merchandise must be placed within your 12' X 12' space. Items may not extend into the street more than 12 feet from the curb or extend behind your booth space. Sidewalks must remain open and clear at all times.
- This is a family event. No flammable, offensive or harmful items allowed.
- No alcoholic beverages allowed.
- No booth sharing is allowed.
- Vendors are responsible for removing all trash from their area and must use Festival trash receptacles or the dumpster for large objects. A trash container will be provided by the organizers.
- The Commonwealth of Pennsylvania requires recycling of all #1 through #7 plastics; clear, brown and green glass; cans and broken down cardboard. All vendors must comply with this.
- Clean-up must be done by the applicant.

The event will be held rain or shine and can be cancelled by the planning committee in case of dangerous or extreme weather conditions

- Booth setup begins at 8:00 AM
- All vehicles out of Festival space by 10:00 AM
